

My teenager has completed the classroom instruction at a driving school. What do I have to do to just teach the in-car instruction?

1st - You must apply with the Texas Department of Public Safety as your student's Instructor. You can find this link at wisedrivingschool.net after you select "**Parent-Taught Curb Buster #104**". You will click on **Apply with DPS** and then you will **Request for a NEW Parent Taught Driver Education Guide**.

2nd - You must provide Wise Driving School with your receipt of your Parent-Taught application with the DPS. Once this is provided, you can purchase the Parent-Taught Curb Buster #104 Driving Only Program (\$100) from Wise Driving School.

****If you choose not to use our partner Curb Buster #104 then Wise Driving School will transfer the classroom hours to you, the instructor of the parent-taught driving only course.****

3rd - After you complete the Parent Taught Driving Only Program your child will receive a final DE-964.

4th -Your child is at least 16 and has held a driver's permit for a minimum of six months then you may schedule your child's driving test at **Wise Driving School** or any DPS office.

Required documents: Final DE-964, 30 hour BTW Parent Log, ITTD Certificate, current VOE and the BTW Parent Taught Affidavit.

5th -Once your child passes his/her driving test at Wise Driving School we will insert all required documentation into a sealed envelope.

6th -You will then take this sealed envelope to any DPS office. Your child will then be required to "Smile Big" for their Driver's License photo!!!

My teenager has already started an online driver's education program. What do I have to do if I want my teenager to complete the classroom instruction with Wise Driving School?

If your child already has their learner's permit then you will transfer their DE-964 to Wise Driving School. You will need to read that companies policy for cancelations and reimbursements. When your child completes the required 32 classroom hours with us, then we will issue a duplicate DE-964.

If your child does not have their learner's permit then you simply let the online driver's education company know that you no longer need their services. You will need to read that companies policy for cancelations and reimbursements. Once your child completes the first three days (6 hours) and passes their permit test with us, we will issue a DE-964. You will then take your teenager along with all required documents to a local DPS office where they will be issued their learner's license.

What's my next step now that my child transferred and completed the required 32 classroom hours with Wise Driving School?

Your child can complete the required in car 14 hours with Wise Driving School (\$350).

OR

You can purchase the Parent-Taught Curb Buster #104 Driving Only Program (\$100) from Wise Driving School.
