My teenager is about to complete the 6 Hour Permit Class at Wise Driving School. What do I have to do now?

1st You will need to visit any DPS Office to get your kiddos Learner's License. As of March 20, 2023**NO WALK-INS ALLOWED** at any DPS Office. You *can make an appointment by visiting* <u>https://public.txdpsscheduler.com</u> Where you will select "<u>Apply For First</u> <u>Time Texas DL</u>" ***Parents, at 7:45am Monday-Friday every DPS office will be posting Same Day Appointments.***

When your son or daughter has received their Learner's License, they may begin their 30 Hour Behind the Wheel Instruction Log at the same time that your student is completing the 26-hour Curb Buster classroom Program on their flash drive.

The 30-hour driving instructor must be at least 21 years old and licensed for at least one year. For this purpose, the driving logs are included on their flash drive. If you would like **to Schedule Private Driving Lessons**, you can simple call or text our office at 940-683-3911.

2nd - After your child completes the remaining Curb Buster Parent Taught Classroom Lessons 4-16 then you will bring their Graded Classroom Log to our office. We will then transfer your student's classroom log to Curb Buster and they will issue your child a Final Driver Ed Certificate (DE-964) which we will keep in your student's file here in our office. *****Your child has 2 Months to complete the remaining 26 Curb Buster Classroom Hours*****

3rd – BEFORE BEGINNING the 14 Hour Instructor Driving Log You must apply with the Texas Department of Licensing and Regulation as your student's Instructor or you may designate someone that is at least 25 years old and has held a license for at least 7 years. Designation Form is provided on the Flash Drive. You can sign up at wisedrivingschool.net after you select the tab "<u>Parent-Taught Curb</u> <u>Buster #104</u>". You will click on <u>Apply with TDLR</u> and then you will select <u>Parent-Taught Driver Education Instructor Designation Services</u> <u>Request</u> where you will be asked to pay TDLR a \$20 fee. You must provide Wise Driving School the TDLR Parent Taught Driver Education Program Guide Receipt Page or the Receipt Number for your students file. 4th -When your child is at least 16 and has held a driver's permit for a minimum of six months and has completed his/her 14 hour In-Car driving Log & the 30-hour driving log then you may schedule your child's driving test at <u>Wise Driving School</u>.

Required documents for Driver's License Road Test

- 1) For Driver's License Only DE-964 Certificate
- 2) 30-hour Behind the Wheel Driving Log
- 3) 14-hour Parent Taught Driving log
- 4) IMPACT Video ITTD Certificate **Must not be expired**

5th -Once your child passes his/her driving test at Wise Driving School we will insert all required documents into a sealed envelope.

Finally, you will then take this sealed envelope to any DPS office. Your child will then be required to "Smile Big" for their Driver's License photo!!!
